Further, on the East of the County (Cumbria) they have easy access into Yorkshire and Lancashire that in that area are greater affiliated in these; people to people / work place / Transport.

Again, connecting mainly to Lancaster, The North West Region.

~This is tradionally due to the geography of the area as the mountainous area to the north and east stopped easy travel and is still so today. ** There are no good big roads. Even the A roads are sometimes difficult in bad weather conditions and they have bends, high hedges and other slow driving conditions.** The **best** routes following the Lune Valley. Not easy crossing The Howgills which ring the area north and east in particular.

It is also of interest that Sedbergh and District was for many years The Ewe Deanery which came under the Bradford Diocese of West Yorkshire.

This is one of the Diocese reaching down the north eastern side of England that there is **under** consideration to several becoming a "Super Diocese" **for The Church of England**

However, Sedbergh and District's Eve Deanery has this very year 2013 become part of the Diocese of Cumbria partly based at Carlisle which area is roughly the same as Cumbria County Councils Boundaries.

Having taken many years possibly from 1974 to affect this transfer out of a Yorkshire Dioceses it seems rather ironic that such land will be thrust harder into The North East.

Along with land that has never been attached in any fashion towards Newcastle and **the** eastern seaboard of Britain, such as "Shap".

It may be, not liked, by "Shap" but it will certainly make things more complicated if several official Bodies who are unconnected and have no normal interchange between themselves, at some distance from each other will have to be consulted on various matters such as planning, highways, health ,transport.

MUST make any planning for Emergencies as well as normal "workings" DIFFICULT for Cumbria County Council AND South Lakeland District Council.

This area is subject to rock falls and difficult weather problems. There are a number of streams, some "wet weather" which have to be culvated or otherwise allowed for. It is work which needs carefully assessment and in some instance requires a convoluted approach due to the difficult terrain. Some of which would be likely to need additional permissions additional to the present ones for both the roads and railway major transport systems if these Extensions to the Parks are allowed.

<u>1i</u>

It seems to be that there a great shout for Tourism and "The Environment" by various Interested Bodies.

Yet this is a bit difficult to see working different to the present.

The "honey spots" of Windermere, Bowness, Ambleside of the townships established in The Lake District National Park have increased three fold in size at least since the 1950's. Nor can it all be blamed to the County of Westmorland or South Lakeland District Council. At separate times both have tried to save land to have it kept "undeveloped" and have been over-ruled on Inquiry. The saga of "School Knot" at Windermere is a case in point. Further it was South Lakeland District Council who refused planning permission for The Lake District National Park to knock down their Art & Craft House at Brockhole to create a completely different structure. Since, they have taken over Planning Permission in the Park area there have been some permission it has been difficult to reconcile with their remit. Such as the very new green pasture house next to the "Romney Hotel" multi apartment site looking down at Waterside (Ambleside) Pier Landings. It is in a very promante site on a world heritage known area. So there is no reassurance regarding these Planning Permission in Received.

Cumbria County has the LARGEST NUMBER of protected, designated land in the whole of Britain.

Apart from the national parks themselves, the forestry commission, the water boards have environmental schemes *Examples*:. One is replacing coniferous trees with mixed woodland. The Water is, in conjunction with the National Trust making a Special Environmental Regime Area for herbage about Thirlemere Reservoir. Then there are Bodies like the National Trust itself which owes many miles of estates, some possessed by Mrs Potter (Mrs Healies). There are also Cumbria Wildlife Trust, Broad Leaf Trust (Man of Oak?) National Society for The Protection of Birds Reservations. Several Sites of Special Scientific Interest. Areas of Outstanding Natural Beauty and "Ruskin's View" at Kirkby Lonsdale overlooking the River Lune and it's valley.

People are proud of this and it is difficult to see how any transfer will improve this glorious sight whether overlooking or travelling in it. Farmers as well as local people are careful of it *and treat it with respect.*

<u>11</u>

Mention Windermere and it's co "hot-spots" you will not think of Kendal "Fells" and the Lune Gorge in the same connection.

The area is much quieter and attracts people to walk, ride, horse or bicycle or otherwise travel, stay or visit to those who would go elsewhere. As such, it is NOT the kind of area which could be improved by attracting more tourists. It already does attract many because of it's character and it's quietness almost by word of mouth. Although townships, groups and clubs i.e. Ramblers Association are active in their promotions. Sometime with, sometimes without the aid of Cumbria County Council, and/or other councils, including South Lakeland District Council who are about. This is why there is the reference at times to "The Lune Gorge" which is a Group comprising various "interests" some of whom are from other Groups, Associations, Councillors, Parish, District or County.

At least two MAJOR NATIONAL FOOTPATHS cross the area along with Bike Trails and others. Bridle Ways, "C" and "D"; and Drovers Roads are common. As are also the remains of "White Roads" and cattle/horse bridges. Park horse's track's crisse crossed the area and they are all represented. It is something wanted and being used by the sort of quiet traveller to the area. Not ARCADE MACHINES.

<u>1m</u>

As the Lune River flows southwards it has created a very green fertile land. But it's headwaters, around "Shap" are very different. Centuries ago trees probably** grew upon the slopes of this pass but now-adays it is poor vegetation or even no grass at all. The "Sweetheart Wood" is such an exception it is pointed out in case you miss it!

The hills flanks are covered with screen and it makes dangerous footing. Even farmers avoid there as do the local breed of sheep that normally climb such steep areas. It is the majesty of it's appearance that attracts but only from a distance. Mountaineers don't travel up it's sides as it is not the type they want to climb. The solitary walker starts off the bus from Kerdal to Kirby Steven (564) BUT ONLY ALONG THERE. Not the 106/A6 bus Route to Shap. A sure indication that the political of the value to a wide range of people in going there. Nor is it likely to change

Many localities in the Lake District have demanded and received cars parks but you won't have that along the A6. Even places like Tebay are quiet on the main street. It is very quiet to hear and hardly any vehicle at all pass along the main street, The A6, since the motorway came. The M6 made a huge difference. **There are many places in the villages to park but it would be extremely difficult to find enough flat areas off the A6 route to place any in many parts due to the nature of the ground.**

<u>1n</u>

Once, many years ago, the whole of Westmorland was covered by farms. Even the people in the towns had strong connections to the families and agriculture of the region.

As the 1700's came the attraction of "The Picturesque" grew *which attracted people to the area* and within a century Wordsworth and other Lake Poets had attracted many more. It was this increase, following the loss of the common in London *to developers* that caused several noteworthy characters to help form The National Trust *which has been especially strong here*. Even so the actual volume of building has forced many connect to the ** Lakes **elsewhere if they didn't already own their own holding in some fashion. Tenanted or otherwise. As The Lake District National Park was formed people flocked to live, work or retire there. Only recently have I written that the same house in Barrow *in-Furness** would sell for another one hundred thousand pounds about Windermere. Just a simple terrace cottage!

The locals, unable to buy their own houses have fled outward to Ulverston, Shap, Carnforth. Even Kendal over this last thirty years has proved too expensive for many. This is because of the many good things about Kendal but price is certainly a factor as, though nudging the National Parks it is outside it. So outside the Premium Price for that position. Though South Lakeland District Council have put convent for some development for locals, for many it has been revoked by South Lakeland District Council as** the locals cannot afford to buy and the developers need to sell the empty units. **

<u>10</u>

Recently a conversation about a certain nearby new "housing" development was held which had its speakers in thrall. Because although decent management salaried not one could conceive of buying there due to the prices asked.

Yet South Lakeland District Council keeps talking about "homes for locals". The fact is that there is little or no land left in the Kendal and many other areas which does not take it away from green pasture.

Many years ago the whole of the land around the whole district was designated as of "Great Landscape Value" but *Since* it has been deliberately changed or ignored for much of the last twenty years because of the forcing to find additional homes or work sites. Extra. Even though at the moment there are many homes, offices and unused work sites all about the district For Sale or To Let. Some might say that this is only tempory due to financial conditions or some such. Yet this has not only lasted since 2008 but has become progressively worse. More premises are vacant, for sale or to rent. Not all can be put down to financial business such as running/bank costs. The period has also seen an increase in regulations, certification and further Health and Safety. Not at least in places like Kendal. It is one reason Ulverston is so popular. But that is not the only reason. It is the fact of being the distance it is from the M6 Motorway, in spite of much improved roads into Furness. It has allowed local people to buy cheaper there. Although it is still costly with regard to transport. Especially for running work vehicles. That is one of the reasons why you are as likely to see a firm from Lancaster as one from elsewhere in the county operating in Kendal/Ambleside.

One of which cheaper areas for living is also off this A6 corridor through Shap.

If the attraction of *a National Park* which occurred after the 1940's occurs again as a critique in areas such as Tebay *due to these areas being put into the National Park(s)* than local people with centuries of connections will be unable to buy against *retirees* from further, more expensive, southward places.

One effect from The Kent River Valley "Kentdale" "Kentdall" is that while in the 1950's every farm field carried cattle and/or sheep, now many lie empty. Often because the farm has been sold and the buildings converted to flats or apartments as all the animals have been sold off. A fear could be that the same could occur along the Shap land Lune Pastures. There will be no farmer left to have an agreed "Meadow Conservation Plan."

<u>1q</u>

Some years ago there was an explosion in the number of super markets in Kendal. The wage that was offered was too low for many and the companies found that they were having to bring staff from outside the district from places like Lancaster.

The same things have occurred in "Caring Service" Agencies to supply enough people to go around serving demands. This is again largely due to not enough low cost houses combined with low wages. If Shap and Kirkby Lonsdale in particular are taken out of the lower cost housing section, a small percentage lost, could exacerbate these problems.

Which would also exacerbate the car volume and the air quality problems already experience around Kendal as more cars are brought in carrying one person from outside the district. At the moment local bus and rail keep "these pressures down" to some extent.

Some of pressures *for low cost staff* are also felt by health/social authorities, hotels, shops and attractions.

<u>1r</u>

The Shap Abbey area has never been developed. There is a small sign on the A6 but generally it has not been pushed by any authority except maybe Eden District Council. Which is a shame as the 105 bus goes directly pass the path to it and the bus fare is already subsidised as a "Country Bus" for Rural Connections so there is a very low cost involved. So a group or a family could pake an excellent day out with the idea of a picnic or a visit to one of the local hotels/cafes for restoration.

But why it has not been "pushed" could be because money is needed, indeed demanded, in the "honey pot" areas. For instance, the roads and pavements in/about Windermere town have just had major works. Yet would things be any different if The Lake District National Park took over? They also have to secure, make safe and do signage as well as the many other "maintance and Improvements" that Cumbria County Council and South Lakeland District Council have had and must continue to do.

Shap Abbey is as worthy as any other historical ruin of The Cistereans Monks as it's more famous cousins in Yorkshire or elsewhere which lie closer to a populous mass. But will the money be available from The Nat Parks?

All from whence it can be "easily" seen.

Unfortunately Cumbria County Council, against objections designated this length as suitable for a Wind Farm corridor. Since, a number of sites are being tested for others to be built. "Though it may since have been altered but" Cumbria County Council, having designated the area *at that time* than seemed to wash its hands of the matter. Yet only today on The News we hear that there may be stronger help against having these windfarms and now Cumbria County Council may also have changed somewhat on this

If you stood in a field you would be unlikely to know if you were in a National part or not due to all appearing the same either side of the line = Beautiful.

Having at one stage designated that land actually outside the National Park as an area of Outstanding Natural Beauty South Lakeland District Council disagreed in some Inquires with Cumbria County Council over the type of Beauty Designation the land should have. But our fears are this "corridor" will follow similar *allowed planning* to an area up on the west coast (Of Cumbria) that from an area of Beauty had so many wind farms allowed that it is now designated as Industrial!

Yet this *same land* is being asked for as part of these Extensions. This has somewhat changed the original boundary proposed ? as made around talked about about inside ???(uncertainty from original copy)

Without it I can see challenge, duplication of, procedures, permissions. Difficulties with extra costs as well as communications as undoubtably the North West Regional Board (CG) Utilities, Trusts etc will be concerned in the same "patch" too.

With all that has been said of gains and losses these would appear "in time". Example as have been offered about past actions, experiments, Plans, Grants or other. Which many say it is an extra Expenses, Paperwork.

It must also be remember that a District Council is ELECTED. It also opens its doors to the public in possibly a greater way than the National Parks do.

Further, a Local Councillor is a Local Person who hears Local People whose families may have had Local Connections at both work and play Locally over a number of years.
