This is a massive development site on the green fields and slopes to the NE of Kendal. It would create a major extension of the town boundary and erase the outlook over open countryside from both the Shap and Appleby Road. It is an area of pleasant rolling hills that forms the base to the view of Benson Knott. In the foreground to the north is the grade II listed Spital farmhouse on the site of the 13th century St Leonard's Hospital. The slope to this historic site forms a particularly pleasing outlook framing the building and at a distance from the town cognisant with its function once as a leper hospital. These views and their significance would be erased and the building hidden by housing.

It is also an area of complicated drainage with a large wet area. Development here must be problematic and increase run-off rates. There were floods on the Kent in 2005 and 2009 and research suggests such extreme events may be more frequent in the future. Think Cockermouth and think again?

There are well-documented transport problems at this end of Kendal with the Shap road junction already at over-capacity. Over the years a few councillors have persisted with the notion that inner or outer relief roads would solve this problem but the expert advice is clear that they are unlikely to be funded and wouldn't work because 75% of the journeys within Kendal start and finish there. Planning and thought has also been given to encouraging walking and cycling, travel to work schemes, park and ride etc. but serious funding has not been committed and there has been a lack of political will. Town traffic is already projected to rise 14% by 2025 and funding for public transport has recently been cut not increased.

It is difficult to imagine how such a massive development at this end of Kendal could be contemplated in the absence of a viable transport plan for the town that will cope with the increased traffic that it will generate.
