We wish to make known our opposition to the inclusion of this site on the development plan for Barbon village on the following grounds:- 1 Situation. The proposed site is beyond the present limits of the village and would compromise the appearance and cohesion of the village and would have the effect of 'ribbon development'				
<u>2 Access</u> Current access to the specific area under discussion is inadequate if not impossible. Access to the village as a whole is restricted by narrow lanes. Any significant increase in traffic to the village on a permanent basis would be undesirable. Because of the lack of public transport, schools, medical services, at least 1 car per household would be necessary.				
3 Need The Barbon Parish plan 2010 indicates that there is little demand for a development area of this size in the foreseeable future, and this is met by areas already approved. There are limited opportunities				

for employment within the village and as the profiles show 64% of people in employment are

employed outside Barbon parish. For families lack of transport and educational facilities would be a problem which would possibly deter them from moving to the village. This in turn would probably

result in new additional housing attracting people without children which would create a bigger imbalance in the age profiles. Some sites have already been allocated for small developments which would meet needs in the foreseeable future.
4 Amenities Reference has already been made to the lack of suitable amenities such as employment in the area, lack of public transport, the necessity for children of all ages to be transported to school, lack of medical facilities, limited recreational facilities especially for teenagers.
5 Environmental Concerns There is no mains drainage. Until there is a scheme in place for the replacement of septic tanks by mains drainage there is likely to be an increase in the amount of pollution entering Barbon Beck. The site under consideration is a haven for wild life. A wide variety of plants grow in this area which has not been grazed or cultivated for many years. These form the basis of a food chain for insects, birds, amphibians and small mammals including bats. Trees and shrubs flourish providing cover and shelter. This is a very precious resource and one which national and local authorities are trying to encourage.
6 Visual Impact Any development in this area would have a very detrimental effect on the uninterrupted views we now enjoy on the approaches to Barbon especially the view from the village hall towards Low Fell. Both residents and visitors appreciate the beauty of this view and to spoil this in any way would be an act of desecration
