## SLDC LOCAL DEVELOPMENT FRAMEWORK – INCORRECT BOUNDARY ON PROPOSED DEVELOPMENT SITE MN22#

I am most concerned that the definitive map you have published for the above site is incorrect, as the boundary outlined on it appears to include some of my land.

I attach a copy of part of the plan attached to Tree Preservation (No: 170) Order 2001 showing the boundary of my property outlined in red. This quite clearly shows that Mr Bell has no access onto Parkside Road.

I would also like to add that I have no intention whatsoever of selling any part of my land in order for a housing development to take place that would then over look my Grade II listed building and garden.

If, despite the reduction in access to Mr Bell's field, you still feel that this site warrants further consideration as development potential, I would be grateful if you would publish a revised plan for this site before the consultation period ends, so that members of the public can make their comments in the knowledge of the correct facts.

Should you wish to visit my property to view the boundary between my property and Mr Bell's proposed development site I would be happy to meet you to discuss this, at a mutually convenient date
