Your comments

There appears to be a demand in South Lakeland for "normal" people to self-build "normal" houses but this is stifled by the lack of affordable plots. The Self-build and Custom Build Housing Act confirms it has been assessed there is a demand nationally for self-build and the local demand should not be denied due to the lack of local data.

In terms of local information currently available:

- The current SLDC self-build register is very poorly publicised and will therefore only be responded to by only a small percentage of potential self-builders.
- Potential self-builders have already discounted the option of self-build due to the longstanding lack of affordable plots.
- There has been the initiation of self-build groups in South Lakeland, notable in Kendal and Ulverston.

As a result, I urge SLDC to bring forward the SHMA in order get a formal assessment of demand as soon as practicable.

It should be noted that amongst the Vanguard Councils (Self and Custom Build Housing Act) is
Teignbridge which has similar issues regarding housing affordability in a "desirable" part of the country.
They have a policy for a compulsory percentage of self-build on developments. I would ask SLDC to
examine the basis for Teignbridge's decision and whether a similar policy should be implemented in
South Lakeland in order to make homes more affordable.
