

I have lived in Silverdale for over 20 years.

With regard to commenting on the proposed plans, I have spent some time physically looking at the sites suggested and offer my view regarding their suitability.

I think I am united with most residents in the village saying that we do not want any more estates or large scale developments. Perhaps small clusters of homes on discreet well-hidden sites would be the way forward?

My main criterion has been the preservation of the special nature of the village of Silverdale within the AONB. Also to minimise disruption to the people who already live there. I realise that there are sites being considered in other villages but I do not feel qualified to comment on those.

Whilst some housing at a lower than market cost may be needed I would make 2 observations.

- People who need lower cost housing may be at work and there is very little of that in Silverdale. They would therefore probably have to travel to Carnforth, Lancaster or Kendal so there are concerns there around the delivery of public transport services in this area/expansion of car usage on our already overburdened country roads.
- With the latest 2 batches of low cost homes in the village, the addition to Lindeth Close and the Whinney Fold development, there was a lot of time spent just getting people to sign up. If my memory serves me correctly I believe that these homes had to be advertised regionally if not nationally to get them occupied. So where is the strong local demand there?

These are only my thoughts/feedback which I offer as I care very much about future development in Silverdale. For my assessment of the suggested sites I have physically walked and driven around them all to get a sense of the following.

- The visual effect of extending the actual outer perimeter of the village as it currently stands. Will development of new homes increase this?
- The effect on the view of the village for people entering it from the main routes in and travelling around within it.
- The effect on public footpaths where the land in question has amenity value, be it National Trust land or farmland.
- The effect on nearby established homes.
- Is the site one where the homes can effectively be hidden but with good access and near to the village centre?

I have created a table for expedience which I hope will be helpful.

It seems to me that there are some obvious sites for development of a small number of homes. The extension of Whinney Fold into site 56 would allow for a site with established access, well hidden, minimum disruption to other properties and the fact that there has always been an expectation by the villagers that this would be the site of any further development. S54 would also be a discreet small site. S70 would be a great site too but is too far from the village centre.
