THIS SITE.

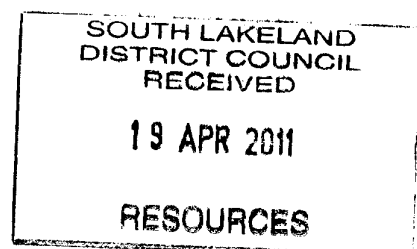
CONCERNS THAT THE S.E OF KENDAL WILL TURN INTO A

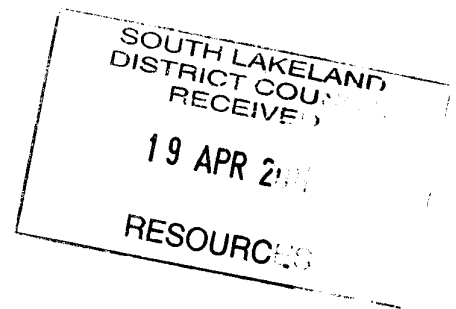
