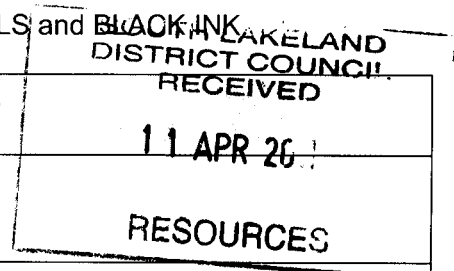

<p>The allocations around Swarthmoor would completely change what is currently a small village surrounded by fields, into a large housing development.</p> <p>I moved here (as have many other residents) because I like the fact that it is a small village in a rural location.</p> <p>I <del>do</del> feel that allowing development of one or two of the fields for housing / community use - plus a small amount of local retail - <u>eg</u> re-installing the local post office - would be appropriate. For example maybe building houses on the fields directly adjacent to the A590, might be appropriate.</p> <p>Any more development than that would completely swamp the existing settlement and its setting.</p> <p>I feel any development in an <u>RN103-108</u> or <u>R688a</u> is totally inappropriate for the above reasons.</p> <p>Similarly <u>R686SW</u> is not only inappropriate for these reasons - but will also make the current drainage situation worse. We already have <u>sewage flooding nearby houses</u> when we have heavy rain, and the <u>topography / soil types</u> make it very difficult, if not <del>impossible</del>, to solve this situation.</p>

Sorry, I do not have specific blocks of land in mind, but it seems to me that it would be far preferable to allow a small amount of building around most of the villages/towns in & South Lakes, rather than building huge housing estates which is proposed for Swarthmoor, Ulverston & Kendal.
