<p>The field is of great natural beauty and has been enjoyed by the public for generations . who use all the field for recreation... Highly used Public footpath. Visible from national park It contains protected species of plants. Visited by many protected animals and birds and bats. Drumlins are in the fields according to a geologist ,and should be preserved The lane has a marked cycle route. Cartmel road very narrow and dangerous,can not accomodate traffic increase.Floods. Wart barrow lane very dangerous for traffic, road floods ,very iced in winter.,blind bend. The site would have to have dangerous access from the narrow roads. Hedgerows on both roads allowed to grow making the narrower and reducing visibility. Inceased danger for pedestrian as is difficult to get in the side to avoid traffic. Large buses and other large vehicles are frequent on Cartmel road. The main street is crammed with cars ,most half on the pavement. This reduces the width of the road,aproaching a single track. An overflow of cars from the new estate are parked in the church grounds and half on the pavement . Primary school in worst place possible at bottleneck. It gets very congested.More cars at peak times will make this situation more dangerous. Traffic has to get on the pavement to pass. Future out of character estates such as the Greendales should be avoided at all costs. Ribbon development of housing would grow the village in a natural way and help keep the character.Housing kept at the lower end of the village would be easier access to amenities. Any housing at the north end of the village would turn roads only designed for horse and</p>			

car into death traps with the upsurge in traffic.

Emergency services travelling to the north end of the village are already compromised by the amount of cars. The main access main street should be kept as clear as possible.

I believe road safety to be utmost importance, a new development here will increase traffic the road system can not support, in north Althwaite.

A recent report tells of the fire brigade having great difficulty getting up the village main street, and an ambulance stuck with flashing light.

Accidents, injuries and maybe deaths will be the sure result.

I have spoken to many people {locals and other} and know of nobody who supports this development.

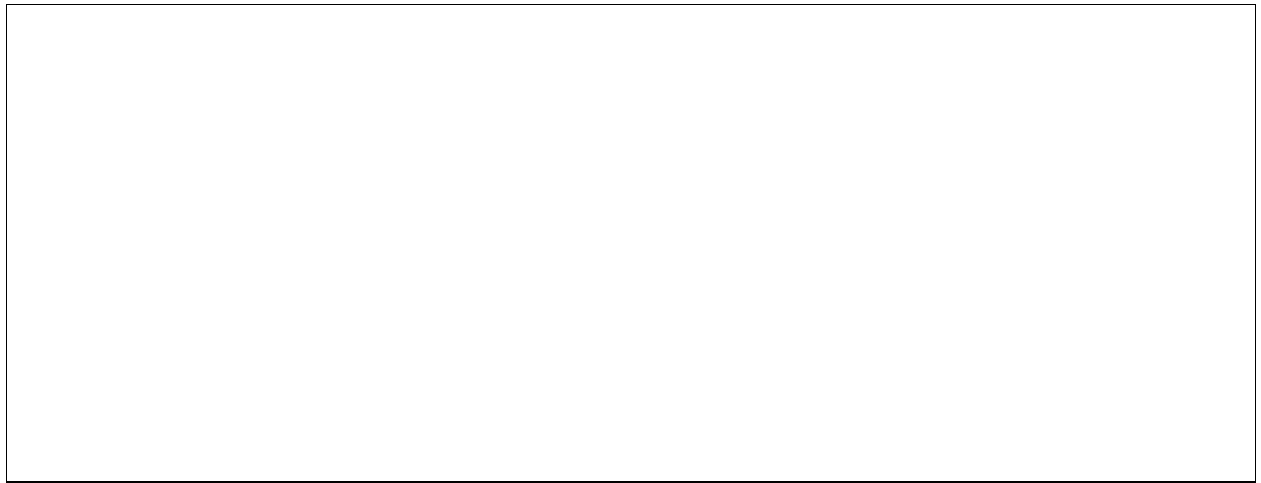
